Proposed Change to Bylaws (First Reading)

Article X, Section 6, Paragraph I.

Currently reads:

<u>Membership Type Transitions</u> – Should an Individual Member wish to switch to a Family Membership (or vice versa), this membership transition may only happen once in a 12 month period. The transition between Individual and Family Memberships outside of the club's normal fiscal year billing cycle will be executed by:

Providing a written request to the Membership Trustee outlining the requested change and effective date in writing. The membership Trustee will not execute any changes without this written and signed request being provided by the member.

The Membership Trustee will calculate pro-rated work hours for the year in question based on the calendar date of the change year.

Example – If a full member wishes to transition from Full to a Family membership at the beginning of 4th month of the year, that years' work hours would be calculated as (4/12*Full Member yearly work hours) + (8/12*Family Member yearly work hours

The seniority date of this Family Membership shall become the seniority date of the Roster member and retain all privileges presently afforded the Roster member.

Membership Type Transitions:


Should an Individual Member wish to switch to a Family Membership (or vice versa), this membership transition may only happen once in a 12 month period. The transition between Individual and Family Membership outside of the club's normal fiscal year billing cycle will be executed by:

Providing a written request to the Membership Trustee outlining the requested change and effective date in writing. The membership Trustee will not execute any changes without this written and signed request being provided by the member.

- B. The Membership Trustee will calculate pro-rated work hours for the year in question based on the calendar date of the change year.
- Example If a full member wishes to transition from Full to a Family membership at the beginning of 4th month of the year, that years' work hours would be calculated as (4/12*Full Member yearly work hours) + (8/12*Family Member yearly work hours

The seniority date of this Family Membership shall become the seniority date of the Roster member and retain all privileges presently afforded the Roster member.

- Should the current Plus One Member of an existing Family Membership wish to transition to a separate Individual Membership or become the Roster Member in a new Family Membership, he/she will be subject to the same application process and requirements as any new member outlined in Article IX above, excepting that the new member initiation fee is waived if the Plus One member has been part of the Family Membership longer than one full year. The seniority date of the new individual membership shall be equivalent to the lesser of either (a) one full year or (b) the length of time the current Plus One Member has been listed on the Plus One's current Family Membership. Plus One Members who were previously Full Individual Membership with full reinstatement of accumulated club seniority, assuming said individual left the club in good standing with all dues/obligations paid.
- In all cases, these transitions between Plus One and Regular Full Membership must be accompanied by a letter to the Membership Trustee from the individual requesting the transition in order to document the required change and effective date for the club's records.
